ARPA (American Rescue Plan Act) funding

Report from ARPA Review Committee - John Cahill (slides on file)

Recommended three applications that they would like to recommend to the administrative working group for review to see if they will meet all the ARPA requirements and could be funded.

1. Island Health Care / Test MV \$105,000 (3 months funding)

2. Martha's Vineyard Commission \$475,000 (for wastewater treatment systems)

3. Martha's Vineyard Airport \$1,500,000 (for wastewater plant renovation)

Leon raised some concerns on process. Discussion followed. It was clarified that at this point any further action will have to wait until the Working Group is ready to propose the process and documents that would be used in the process. It was also clarified that MV Commission project is not an R&D project. Leon asked if Christine had a conflict of interest because she is member of the MV Commission. Christine said she can find out.

Report from ARPA administration working group - Peter Wharton

Working group reviewed the MOU with Plymouth to get the documents so county documents can be developed and same questions can be asked of all applicants so we can determine if they will comply with all the federal regulations. It was clarified that it is not an intention to open the process to any new applications. Discussion followed.

John/Don moved to recommend the three applications and amounts form initial screening committee to a full legal and regulatory review by the working group
